On November 13, 2024, A. Soriano Corporation (Anscor) signed a Deed of Sale with Navegar I (Singapore) PTE. LTD. to acquire a minority stake in TBG Food Holdings, Inc. ("TBG") for a total consideration of PHP1,609,300,000.00. TBG, also known as The Bistro Group is a premium casual restaurant operator in the Philippines, owning and operating over 200 full-service restaurants across 23 brands, including iconic names such as Italianni's, TGI Friday's, and Texas Roadhouse.
